2. The Contractor should provide following document at the time of submission of Quotation:-

(A) ENVELOPE NO. 1 DOCUMENTS)

The first envelope "**Envelope No.1**" shall contain the following documents.

- i. The Earnest Money Deposit shall be paid via Demand Draft mode only. The DD should be enclosed. **(D.D. of Rs. 1000)**
 - ii. Copy of Registration PWD/MSEB/MJP Certificate & Electrical Contractor License Copy.
 - iii. Copy of Details of work done of similar typed in last 5 years.
 - iv. Copy of Income tax return FY 2022-23, i.e. AY 2023-24
 - v. Copy of pan Card.
 - vi. Copy of valid registration certificate under good and service tax Act 2017 & GSTR 3 B copy as on March 2023.
